

14 DAY TRY AND BUY AGREEMENT

AGREEMENT ("Agreement") made effective this _____ day of _____, _____
("Effective Date") by and between _____,

a _____ corporation ("Evaluator"), with its principal place of business at:
_____, and WIRESOFT Net, Inc.

("Wiresoft") a Delaware corporation, with a principal place of business at: 600 Vine St, Suite 2500, Cincinnati, OH 45202. The parties do hereby agree as follows:

Try and Buy Period. The Try and Buy Period shall begin upon delivery of the Wiresoft Sentry ("Unit") to Evaluator and shall continue until the earlier of (a) the return of equipment and all associated materials by Evaluator; or (b) fourteen (14) days after delivery of the Unit ("Evaluation Period"). Within ten (10) days of the Evaluation Period, Evaluator must return to Wiresoft the hardware, the installed code, any documentation, and any other related materials ("Product") at Evaluator's expense or Evaluator will have been deemed to have purchased the Product.

Payment. *A VALID CREDIT CARD NUMBER MUST ACCOMPANY THIS TRY AND BUY REQUEST BEFORE UNIT WILL BE DELIVERED. IF UNIT IS RETURNED IN GOOD WORKING CONDITION WITH THE TAMPER PROOF SEAL INTACT AND IN ITS ORIGINAL PACKAGING WITH ALL PROVIDED COMPONENTS PRIOR TO TEN (10) DAYS AFTER THE END OF THE EVALUATION PERIOD, NO CHARGES WILL BE INCURRED. IF UNIT IS NOT TIMELY RETURNED, EVALUATOR SHALL IMMEDIATELY BE CHARGED THE PURCHASE PRICE FOR THAT UNIT. SUCH CHARGE SHALL BE MADE ACCORDING TO THE PAYMENT INFORMATION PROVIDED BY EVALUATOR AND AS STATED AT THE END OF THIS AGREEMENT.*

Trademarks and Trade Names. Wiresoft and Sentry Security Platform are trademarks of Wiresoft.

Representations and Warranties. Representations and warranties related to the Product are contained in a separate document and nothing herein shall be deemed to alter, amend or supersede such warranties.

Proprietary Rights. The risk of loss of the Unit shall shift to Evaluator upon delivery of the Unit. Wiresoft shall retain ownership in and to the Product until payment for the Unit is received in full. Evaluator shall not use or disclose any information related to the Product or any documentation or other confidential information, except as expressly permitted by this Agreement. Evaluator shall not remove Wiresoft's copyright notices, trademarks, restricted rights legends or any other notices from the Product. Evaluator shall not attempt to reverse compile or reverse engineer the Product.

Unauthorized Use or Copying. Except as expressly permitted under this Agreement, Evaluator shall not copy, modify, or reproduce the Product in any way, nor shall it permit third parties to do so. Evaluator shall fully cooperate with Wiresoft in any action relating to enforcement of Wiresoft's proprietary rights.

Limitation of Liability WIRESOFT'S LIABILITY ARISING OUT OF THIS AGREEMENT, SALE OF THE PRODUCT, OR PROVISION OF SUPPORT SERVICES SHALL BE LIMITED TO THE AMOUNT PAID BY THE EVALUATOR FOR THE PRODUCT OR SUPPORT SERVICES. IN NO EVENT SHALL WIRESOFT BE LIABLE TO EVALUATOR OR ANY OTHER ENTITY FOR ANY SPECIAL, CONSEQUENTIAL, INCIDENTAL OR INDIRECT DAMAGES, HOWEVER CAUSED, ON ANY THEORY OF LIABILITY, AND WHETHER OR NOT WIRESOFT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THESE LIMITATIONS SHALL APPLY NOTWITHSTANDING ANY FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY.

Governing Law. This Agreement shall be governed and construed under the laws of the State of Ohio, without reference to conflicts of law principles. Any claim or cause of action arising out of this Agreement shall be brought in the federal or state courts located in Hamilton County, Ohio. The prevailing party in any legal action brought by one party against the other and arising out of this Agreement shall be entitled, in addition to any other rights and remedies it may have, to reimbursement for its expenses, including court costs and reasonable attorney's fees.
